

United Kingdom Sovereign Release Calendar For 2024

This calendar announces two dates for the potential release of both solicited and unsolicited sovereign credit rating actions, in accordance with Regulation (EC) No 1060/2009 as it forms part of the domestic law of the United Kingdom by virtue of the European Union (Withdrawal) Act 2018. It includes sovereign issuers that are covered by a Lead Analyst based in the UK, as required by the regulation cited above and, in order to provide greater market clarity, it also includes UK sovereign issuers that are covered by Lead Analysts based outside of the UK. This calendar may be updated as needed during the year.

This calendar does not incorporate dates where Moody's will release what Moody's terms newly issued credit ratings assigned in the

Subsequent Ratings Process or credit ratings from which a provisional notation has been removed in the Anticipated Ratings Process.
